1. Purpose

This policy has been developed to protect all Staff, Students, Contractors and Visitors from exposure to secondhand smoke and to assist compliance with the Health Act 2006.

2. Policy

It has always been the policy of **Great Marlow School** that the school is smoke free. An extension to the policy came into effect on Sunday 1st July 2007 that smoking is prohibited on all the school premises. This includes school vehicles and school grounds.

This policy applies to all employees, students and contractors and visitors and to those using the premises outside normal school hours.

Students are not allowed to be in possession of cigarettes or lighters whilst at School, on the periphery of the site, on their way to or from school, or whilst engaged in School activities.

3. Implementation

Overall responsibility for policy implementation and review rests with the Headteacher. However, all staff are obliged to adhere to, and support the policy. The School will regularly inform all employees, students and contractors of the policy and their role in it's the implementation and monitoring. For staff employed after 1st July 2007 the policy forms part of the Contract of Employment. The Site Manager will advise all contractors working on site of the policy and those who hire the school premises for out of school hours events are advised of the policy in the school letting agreement.

4. Non-Compliance

Local disciplinary procedures will be followed if a member of staff, or student, does not comply with this policy. Those who do not comply with the smoke free law may also be liable to a fixed penalty fine and possible criminal prosecution.

5. Statement of Policy on Cigarette Smoking

Great Marlow School encourages students not to smoke cigarettes by means of its PSHE curriculum and by other pastoral contacts. Great Marlow School is a non-smoking establishment that fully supports legislation making it illegal to smoke on public premises.

Smoking, or being in the company of smokers or being in possession of smoking materials on the school premises or when travelling to and from school, is not permitted.

6. Sanctions

First

Contact made with parent/carer from Learning Guidance & Support and after school detention – written work on harmful effects of smoking

Subsequent

Fixed term external exclusion may be warranted for students who are caught smoking more than once, with a recommendation to parents to seek advice from GP.

Persistent Smokers

A member of the Leadership Team may arrange for them to spend breaks and lunchtimes in isolation in a designated room for an extended period.

We are concerned for the health of all our students and shall attempt to offer counselling for those who are addicted to the habit but seek parents' support in this respect as well as their support of our disciplinary measures.
