How to make a donation using Gift Aid....

In order to make a Gift Aid donation you will need to make a Gift Aid Declaration. By completing this leaflet, Great Marlow School can cover every gift made to the school for whatever period you choose, and can cover gifts you have already made and/or gifts you make in the future.

A Gift Aid Declaration must include the following information:

- **Your Full name**
- **Your home address**
- **Details of your donation**
- **Amount**
- **Frequency of donation**
- **Commencement date**
- **Termination date**
- **Your Bank/Building Society details**

If you pay income tax at the higher rate, you must include all your Gift Aid donations on your Self-Assessment Tax Return if you want to receive the additional tax relief due to you.

Please notify the school if you:

- **Wish to cancel this declaration**
- **Change your name or home address**
- **No longer pay sufficient tax on your income/capital gains**

The Gift Aids scheme is for gifts of money by individuals who pay UK tax. Gift Aid donations are regarded as having basic rate tax deducted by the donor. Charities take your donation - which is the money you have already paid tax on - and reclaim the basic rate tax from HM Revenue & Customs (HMRC) on its "gross" equivalent - the amount before basic rate tax was deducted.
