Dear parents / carers,

I am writing with information about this year's examinations. Some important information is covered here and a copy of the letter will be available on the school website under Examinations Information.

## Process to date

Students have been informed of the marks proposed for any internally assessed components of their subjects. The deadlines for requesting internal reviews of these marks have now passed in all subjects except Child Development, Design & Technology and Food Preparation & Nutrition (deadline 10<sup>th</sup> May for all) and Art (deadline 21<sup>st</sup> May). These marks are now being / will now be submitted to the exam boards for external moderation. This moderation process ensures that our marking is in line with national standards. It is important to note that the marks submitted to the awarding bodies are subject to possible change and should be considered as provisional still.

The grades attained by students during any mock examinations will **not** form part of grading in subjects and we have **not** been asked to submit these marks to the awarding bodies. Nevertheless, these practice examinations have been an excellent opportunity for students to assess their progress, as well as getting used to the formalities of sitting examinations. We were impressed with students' positive attitude. Staff are continuing to work hard to make sure that everyone is well prepared for the forthcoming examinations.

Students have received their final timetable. Please check this carefully for examination clashes. If there is a clash, and your child has not yet received an email about this, it is their responsibility to inform us through [exams@gms.bucks.sch.uk](mailto:exams@gms.bucks.sch.uk) as soon as possible. If an examination is timetabled to finish after 2.45 pm, it could mean that students will miss the school bus by the time they finally leave the building, so please be prepared to make alternative arrangements for them to get home on those dates.

'JCQ: Information for candidates for written examinations' is printed on the reverse of the timetable. We would be grateful if you would read through this carefully with your child. The relevant JCQ document can also be found [here](#) and on the website under Examinations Information – Information for candidates and parents / carers. It is relatively short but contains incredibly important information. In addition, students are already aware that:

- pens must be black and non-erasable
- pencil cases must be transparent with no writing / labels
- water bottles must be transparent with no writing / labels
- we do not have spare equipment to lend to students who forget something

## Toilet Policy during examinations

To enable all students to have the chance to perform to the best of their ability during the public examinations, we have a short [Toilet Policy](#) that we have explained to students already and would like you also to read through very carefully with your child.

## Special Consideration

Candidates are eligible for special consideration “if they have been fully prepared and have covered a whole course but their performance in an examination **is materially affected by temporary adverse conditions beyond their control at the time of the assessment**”.

There are two possibilities:

- The candidate is present for an examination but is disadvantaged.
- The candidate is absent from an examination for an acceptable reason.  
There are minimum requirements for enhanced grading in this case.

JCQ (Joint Council for Qualifications) outlines full details of the special consideration process in its [guidance](#). If you feel that your child may be eligible for special consideration for a particular examination, they must complete this [MS Form](#) **immediately before, or on the day of, the examination**. This must be done from a GMS student email account.

Mrs Smith, our Examinations Officer, will apply for special consideration on behalf of a student, should the stringent JCQ criteria be met, when the relevant MS Form has been completed. She will inform the student if any application has been submitted.

Monday 3 <sup>rd</sup> June	The only lessons still provided are those where exams are still to take place – attendance at these lessons is encouraged, but is not mandatory

It is vital that all students are available on the 3 examination contingency dates. These dates could be used by the examination boards if any examination has to be moved. If an examination is moved and a student is not available, there will be no special consideration given.

## **Graded Music**

If your child has achieved a graded music examination at grade 6 or above, or is due to take one before the end of this term, please ask them to bring the certificate to reception for a photocopy to be taken. This enables performance points, equivalent to at least a GCSE grade 7, to be added to the student's points total in the summer. Whilst this does not affect entry into GMS' sixth form, it supports our whole school results and may be important as part of a student's points score for entry into a sixth form elsewhere.

I wish all students the best with their revision and encourage them to continue to look after their wellbeing in these challenging few months. Almost there! We are proud of the approach taken by the students so far and are sure that these examinations will allow them to show what they are capable of.
